

1 Year Casper Glass Warranty

Thank you for your interest in the products and services of Premier Tech Repair, LLC.

This 1 Year Warranty applies to the Casper Tempered Glass, and only for Casper Tempered Glass, purchased from Premier Tech.

What does this 1 year warranty cover?

This Limited Warranty covers any defects in material or workmanship under normal use during the Warranty Period.

During the Warranty Period, Premier Tech Repair will replace, at no charge, products or parts of a product that proves defective because of improper material or workmanship, under normal use and maintenance. This includes accidental damage, for up to (1) year. If the tempered glass breaks from a fall, it will be replaced, at no charge, for (1) year. If the iPhone glass breaks with the tempered glass applied, you will receive a \$40 credit towards a screen replacement.

What will we do to correct problems?

Premier Tech Repair will repair the Product at no charge, using new replacement parts.

How long does the coverage last?

The Warranty Period for Casper Tempered Glass purchased from Premier Tech Repair is 1 Year from the date of purchase.

What does this limited warranty not cover?

This Limited Warranty does not cover any problem that is caused by:

- Damaged or destroyed by natural causes including but not limited to lightning, flood, or other natural disaster
- Theft or loss of the Casper Tempered Glass.

What do you have to do?

To obtain warranty service, you must first contact us to determine the problem and the most appropriate solution for you. Once contacted, we will travel to your location of choice within Cape May County and replace your Casper Tempered Glass.
