

# Standard 3-Month Warranty

Thank you for your interest in the products and services of Premier Tech Repair, LLC.

This 3-Month warranty applies to Physical Goods, including Replacement Screens purchased from Premier Tech Repair.

## What does this 3-Month warranty cover?

This 3-Month warranty covers any defects in material or workmanship under normal use during the Warranty Period.

During the Warranty Period, Premier Tech Repair will repair or replace, at no charge, products or parts of a product that proves defective because of improper material or workmanship, under normal use.

## What will we do to correct problems?

Premier Tech Repair will repair the Product at no charge, using new or refurbished replacement parts.

## How long does the coverage last?

The Warranty Period for Physical Goods purchased from Premier Tech Repair is for 3 months from date of purchase. Warranty does not transfer with new ownership.

## What does this 3-Month warranty not cover?

This 3-Month warranty does not cover any problem that is caused by:

- Conditions, malfunctions or damage not resulting from defects in material or workmanship
- Conditions, malfunctions or damage resulting from negligence, improper maintenance or modification
- Damaged or destroyed by natural causes including, but not limited to lightning, flood, or other natural disaster
- Theft or loss of the Physical Goods
- The owner shall assume all risk of loss or damage to the Physical Good while in transit to us.
