## How Long Does This Coverage Lasts

The standard limited warranty is one (1) year from the date of original repair.

## Who is Covered

Only the original purchaser of this product is covered under this limited warranty. This limited warranty is not transferable to subsequent purchasers or owners of this product.

## What Premier Tech Repair Will Do

Premier Tech Repair will, at its sole option, provide one of the following three remedies to whatever extent it shall deem necessary to satisfy a proper claim under this limited warranty:

For Smartphones and Tablets:

1. We will repair, free of any charge for **parts and labor** to complete the repair and restore this product to its proper operating condition. Premier Tech Repair will also pay the shipping costs necessary to return this product once the repair is complete.



2. Replace this product with a direct replacement or with a similar product deemed by Premier Tech Repair to perform substantially the same function as the original product.
3. Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.

### For Desktops and Laptops:

1. We will repair, free of any charge for **labor only**, to complete the repair and restore this product to its proper operating condition. Premier Tech Repair will also pay the shipping costs necessary to return this product once the repair is complete.
2. Replace this product with a direct replacement or with a similar product deemed by Premier Tech Repair to perform substantially the same function as the original product.
3. Issue a refund of the original purchase price less depreciation to be determined based on the age of the product at the time remedy is sought under this limited warranty.
